



Contract for 2021-2022 (September 1st –June 17th)

Tuition charges for 2021-2022 school year are as follows: The school year tuition is divided into 9 months, with 8 equal payments and 2 half-payments for December 2021 and June 2022. June 2022’s half payment is due June 2021.

I UNDERSTAND AND AGREE TO THE FOLLOWING TERMS:

Registration at Lakeview Montessori School includes contractual agreement to the philosophy and policies described in the Parent Handbook, which I have accessed on line, including the school pest control policy and school emergency policy. I understand that the school may amend the handbook at anytime and that written notice of changes will appear in the school newsletter. I agree that I am responsible for understanding amendments and for requesting a newsletter if I cannot access it on Lakeview Montessori’s website.

Tuition payment terms:

Lakeview Montessori School charges an annual tuition for the school year, divided into 8 full payments and 2 half payments. Tuition payments for September 2021 through June 2022 are due in full each month regardless of attendance, vacations, family emergencies, school closure, holidays, student illness, etc. School closure days due to weather or power outages are not made up.

- 1. Due by June 1st, 2021 A non-refundable June 2022 deposit equal to one-half of your child’s monthly tuition. This amount represents tuition through June 17th.
2. Payment #2-#8 Due on the first school day of each month from September 2021 through May 2022, with December being a half payment. The registration fee of \$250.00 per child is nonrefundable and is required with this application.
3. If your child is withdrawn before the end of the school year, the school’s withdrawal form, available on our website, must be completed and submitted. Thirty days’ written notice must be given by the first day of the month in which the withdrawal will occur. If you fail to give such notice, you are liable for the following full month’s tuition regardless of whether your child no longer attends the school or only attends for part of the month. Additionally, withdrawing your child before the end of the school year results in the forfeiture of the last half-month’s tuition deposit. THERE ARE NO EXCEPTIONS TO THIS RULE.
4. Once you have registered, if you decide to reduce your schedule, you must give thirty days written notice by the first of the month, and pay a new \$100.00 non-refundable schedule reduction/registration fee for your new position. Your prepaid last month deposit will not be reduced to reflect a schedule reduction, and your child’s attendance in June 2022 will be based on their most recent schedule attended.
5. Summer school is enrolled and billed separately from this contract.
6. Any child picked up after 6:00 PM will be charged \$7.00 for every 5 minutes or portion thereof after 6:00 PM.
7. Monthly tuition is due on or before the first day of the month. A \$20.00 late fee will be charged on payments received after the fifth of each month. Additionally, there is a \$30.00 handling fee for any returned check. Finally, interest on past due balances is 1.5% per month.
8. Submission of an application (including the return of this contract), does not guarantee enrollment.
9. Lakeview Montessori School reserves the right, in its sole and absolute discretion, to revoke enrollment when it deems it necessary. This includes revocation of enrollment after a student has already begun attendance. Lakeview Montessori School will determine on a case-by-case basis whether there will be any refund (in whole or in part) of any deposits paid if enrollment is revoked. The revocation of enrollment by Lakeview Montessori School does not automatically guarantee a refund of any deposits paid.
10. In the event an attorney is employed to collect any amount due hereunder, then the family is responsible for payment of all attorneys fees and costs incurred by Lakeview Montessori School for the collection of the amount due.
